a) Funding mechanism discussion

Mitch opened the discussion by explaining the types of building funding mechanisms available. He identified two options: bonding and fundraising (donation). Next, he described the types of bonds that could be asked for, such as City bonds versus a recreation district bond. Mitch stated that the Committee needs to get to a position where a recommendation can be presented to Council. There is a ball park figure for the building costs and a ball park plan for location. The focus of today's discussion is on what type of funding is the Committee going to recommend. Chris Scholes brought up the possibility of an auditorium district. The auditorium district is a tax on hotel rooms and could be a possible option as well. Discussion on bonding followed. Next was a discussion and clarification on the advantages/disadvantages of the bonds versus a recreation district. The idea of pursuing upfront fundraising before going to Council and the public to ask for a bond would be beneficial and discussion on the possibility of naming rights or sponsorship's for sections of the center followed. It was determined that further discussion will take place at the next meeting to establish how the Committee will move forward.
