- a) Update on FAA Projects

The Airport Manager, Bill Carberry, discussed air service. Starting December 1, 2021, the airport will have 1 Delta flight to/from Salt Lake City. We anticipate a few diversions this year, depending on the weather. Airport Manager, Carberry, along with the City Manager, Travis

Rothweiler, and Chamber CEO Shawn Barigar traveled to St. George UT to meet with SkyWest officials. SkyWest informed them that the United flight to Denver would end on December 1, 2021. In addition, they were informed that the Delta flight to Salt Lake City would be once daily, until Spring. SkyWest stated that we should return to 2 flights daily in April.

- a) Planning for the 2023 Air Magic Valley Airshow
Bill Carberry, Airport Manager, and Jim O'Donnell, Board Member, discussed past airshows and possible future airshows. Steve Kolar has taken over as the director. Both Jim and Steve were present at the City Council meeting on October 23, to introduce Steve Kolar as the incoming Airshow Director. ICAS will make an announcement in December to see if the Blue Angels will have us on their schedule for 2023.
