1) Call Meeting to Order

Chair Smith called the meeting to order at 1:03 PM. A quorum was present.

2) Items of Consideration

- a) Approve the September 2, 2021 and September 8, 2021 meeting minutes.
White moved to accept the minutes as submitted; Youngman seconded. Everyone voted in favor of the motion.
- b) Approve completion of the wall mural project located on the alley wall of City Hall. Dedication could take place during the December 13th URA Board meeting.
The mural, Magic of the Valley, has been completed by artist, Matt Sunderman. Youngman motioned to accept the mural as completed and authorized final payment; White seconded. Everyone present voted in favor of the motion. Dedication will take place at the December 13th URA Board meeting. An identification plaque will be installed in the near future.

Since the artist had to edit his original mural submittal to fit the new wall location, he voiced interest in adding to this mural in the future. This topic will be discussed at a later meeting.

- c) Potential Projects
Art Recognition Board: White presented the update to the committee. The search for a location continues. White has been researching Twin Falls art pieces to be included on the board as well as trying to get artist's statements. White asked the committee to look at the information she had gathered so far to see if they could help with missing information. McBride has been taking pictures of the art pieces to be included on the website that the library will host. A QR code will be created to link to the art website. A cost estimate for pamphlet printing has been requested from Five Fish Press.

White introduced a metal sign option. It would be less expensive than the encased type previously presented. A new one would need to be made each time it is updated. White moved to move forward with a 4'x4' ACM panel for the public art directory; Dennis seconded. Everyone voted in favor of the motion.
