STAFF REPORT

1. Approve minutes of the January 8th 2014 meetings.

The Commission needs to approve or amend the proposed set of minutes.

2. “Friends of Muni” Fundraising Tournament - Staff

As staff has mentioned at previous meetings, we have been working with Jim Hiskey to further enhance the “Friends of Muni” tournament by bringing in some former PGA professional champions. One confirmed commitment is Bill Rogers, the 1981 British Open champion. Another possibility is Don January, 1967 PGA Champion.

The drinking fountain by tee box #1 is in memory of Sonny Hiskey, Jim’s brother. The Hiskey family history with the golf course goes back to the 1930’s as P.M. Hiskey was the Superintendent of the course and later became superintendent for the Parks & Recreation Department. P.M.’s three sons all became professional golfers.

Jim Hiskey is proposing to change the name of the tournament to the “Sonny Hiskey Memorial” tournament. Staff feels if the “Friends of Muni” is still used in the name, it could work. Possible names could be the “Sonny Hiskey Memorial, Friends of Muni” tournament or switch it around, the “Friends of Muni, Sonny Hiskey Memorial” tournament. Also the Hiskey family is wondering if any of the funds could be dedicated to build a water fountain feature on the back side of the green on # 18, replacing the flower bed that staff installed a couple of years ago. The old drinking fountain would then be removed. Some ideas would be a fixed amount of the proceeds or a percentage of the proceeds could be dedicated to the proposed feature. A cost estimate for this feature has not been developed.

At the February meeting, the Commission directed for Steve and Dennis to discuss with the Hiskey family the following:

- For this year, the tournament could be dedicated to Sonny Hiskey, with a percentage of funds raised over \$10,000 would go to the building of the water fountain feature. The percentage is negotiable.

- This dedication is only for one year. The “Friends of Muni” tournament is for improvements for the golf course, not a memorial fundraising tournament.
- If the family wishes to host a “Sonny Hiskey Memorial” fundraising tournament, they can like the other entities do with their fundraising tournaments each year.

Both Steve and Dennis spoke with Doug Harper who is working with Jim Hiskey on the tournament and explain to Doug the direction the Commission gave us. Jim Hiskey will be in Idaho the first part of March, hence the moving of our meeting to Friday March 7th, so Jim Hiskey could address the Commission in person. Dennis spoke with Jim and told him the Commission’s direction. He felt comfortable with them, but wanted to discuss the percentage of the \$10,000, Dennis told Jim that was negotiable. Also Dennis told Jim that a different type of memorial for Sonny Hiskey might be better than the water feature behind green # 18.

MINUTES

With the Chairman and Vice-Chairman absent, Brett Semple called the meeting to order at 11:05 am.

Item # 1 Welcome New Council Liaison

Greg Lanting was appointed to be the Golf Advisory Commission's Council liaison at least the next two years. Greg has served before as the Commission's liaison. Welcome back Greg.

Item #2 Approve minutes of the January 8th, 2014 meeting.

Rich Birrell made a motion to approve the minutes and Teena Thompson seconded the motion. Motion passed with a unanimous vote.

Item #3 "Friends of Muni" Fundraising Tournament

With the direction from the City Council on sub-committees for Commissions, formation of sub-committees will have to be voted upon and approved by the Commission, and then those meetings have to follow the same format as the regular Golf Advisory Commission meetings. The Golf Advisory Commission was in favor of not having sub-committees, but to have the work done for the "Friends of Muni" tournament at the regular monthly Commission meetings.

After a lengthy discussion, the Commissioners were in agreement with the following directions for Steve and Dennis to discuss with the Hiskey family concerning their requests:

- For this year, the tournament could be dedicated to Sonny Hiskey, with a percentage of funds raised over \$10,000 would go to the building of the water fountain feature. The percentage is negotiable.
- This dedication is only for one year. The "Friends of Muni" tournament is for improvements for the golf course, not a memorial fundraising tournament.
- If the family wishes to host a "Sonny Hiskey Memorial" fundraising tournament, they can like the other entities do with their fundraising tournaments each year

Dennis and Steve will take the recommendations and concerns of the Commissioners back to the Hiskey's for their consideration.

Item #4

Opening on Commission

The Mayor's direction for interviews on openings are for the Council Liaison, staff, and the Chairman to interview the applicants, then make a recommendation to the Mayor, and then the Mayor will make an recommendation to the Council on the appointment.

Also Jack Jardine's term will end, but Jack is eligible to serve two full three year terms since his first appointment was only for a partial term. Jack has requested to be re-appointed. Again after the Council discusses the interview, staff will receive direction from the Mayor on re-appointments.

Attached is an application for the opening on the Commission, if any members know anyone that would like to serve, please give them an application or have them contact staff and we'll get them an application. We would like to have this person on board at our March meeting.

Gale was ill today so the Commission could not say thanks to Gale for his six years of service on the Commission. Dennis will present Gale his plaque at a future City Council meeting. Once that date has been set, Dennis will notify the Commission of that date.

Item #5 2013 Golf Report from Steve Meyerhoffer

Steve handed out a report for the 2013 season showing the number of rounds played, season passes sold, and other information along with how it compares to the 2012 season. (Attached).


Steve also requested to put sand containers with lids at the par three tees for filling in divots.
