2) Consent Calendar

- a) Approve July 10, 2018 meeting minutes.

MOTION: ZJ Martinez moved to accept the July 10, 2018 meeting minutes as written. Sherry Murray seconded the motion. Roll call vote showed all members present voted. Motion passed 8 to 0.

3) Items of Consideration

- a) Consideration of a request to raise the Twin Falls recreation fees.

Stacy McClintock presented the request for increasing Twin Falls recreation fees. Stacy gave a history of when the fees were last changed and also indicated that we are moving to doing background checks through a company and that the fee increase will help offset the cost of the background checks. The department is also looking at changing the baseball/softball tournament field usage fees. A discussion with explanation ensued in regards to the background check. Questions were raised over the fee that was set. Discussion ensued and questions were asked and answered.

MOTION: Rich moved to accept the proposal to send the request to raise fees to the City Council. ZJ Martinez seconded the motion. Roll call vote showed all members present voted. 8 to 0.

Aaron brought attention to the fact that the NE corner of the park seems to be flooded. Sherry inquired about the numbers at the City Pool. John will send out a group email with the information the Commission requested.

Wendy reminded the Commission that they needed to get back on the Master Plan discussion. She also offered to provide images and information in regards to the Community Center power point presentation.

Wendy also reminded the Commission that if there are items they would like to discuss those items need to be put on the agenda because if they are not on the agenda all that can be done is discussion, no action can be taken. The agenda can not be added to any more on the day of. She asked the Commission if there were any items that they would like to be talked about or direction given to the department. ZJ Martinez would like an activity programming discussion. Rich Birrell asked about the Canyon Rim Trail and if there would be a parking lot at the Evel Knievel jump-site. Wendy indicated that right now it is a dirt road access and open parking. If there were to be any improvement out there like there is at Auger Falls that would trigger a 2 1/2 million code required paved road, curb, gutter and sidewalk. Aaron asked for a financial report for the programs to see if they meet financial goals and to see what the future needs would be. Aaron recommended reviewing the Flagstaff Arizona master plan as it encompasses the fees and programming.
