3) Items of Consideration

- a) Request to approve the minutes from the October 1, 2019 meeting.
MOTION: Perri Gardner moved to approve the minutes. Suzzane Cawthra seconded the motion. Voice vote showed all members present voted in favor of the motion.
- b) Artist Plaque for the mural on Claude Brown's building.
In 2018, artist plaques were posted next to the murals on the Commons wall. The recently installed mural on Claude Brown's wall does not have an artist plaque and the committee agrees one should be added. The mural is of the historical Idaho Department Store that was across the street and is scheduled to be demolished soon. The building does have a historical sign hanging on the front, but it belongs to the Historical Preservation Committee (HPC). Nathan Murray agreed to talk to the HPC and see if they would like to hang it by the mural if approved by Brown's. Tony Prater

offered to draft a new plaque and present it at the next meeting. Leon Smith offered to talk to Claude Brown's about adding a plaque next to the mural on the wall. Nathan Murray will also verify if any codes exist for hanging new signs in the downtown area.

c) **Potential future projects.**

Discussion included mural paintings on buildings and signs, repainting existing signs, and different types of interactive art displays to help beautify the downtown district. A community art project along the fencing around the construction area at 160 Main was suggested. Other possible locations were discussed. Committee will listen for suggestions and ideas from the downtown businesses.
