1) Call Meeting to Order

Leon called the meeting to order at 01:34 PM. A quorum was present. Leon introduced and welcomed Mike Youngman.

2) Items of Consideration

a) Request to approve the April 20, 2021 minutes.

MOTION: Carolyn moved to approve the April 20, 2021 minutes. Dennis seconded the motion. Unanimously approved.

b) Potential Projects

Mural Plaque: Tony presented text for the plaque to be added next to the mural on Claude Brown's wall; committee approved. He will talk to the Historical Society about the plaque design and present it at the next meeting.

Recognition Board: Lytle Signs provided a very rough draft of an artist recognition board. The board would measure 36"H x 24"W. It would be a digitally printed overlay on white HP vinyl applied to custom routed 3M ACM panel with graffiti resistant laminate applied for ease of updates/maintenance. The board would be housed in a protective environment. The boundary area was discussed and it was suggested to include all public art within the area. The title was discussed. Marjorie and Carolyn will have Lytle Signs incorporate the new ideas and present a new draft at the next meeting. Carolyn and Tony will try to get a list of all art in the area.

Leon and Dennis attended the Public Art Commission meeting on May 4th to introduce the URA Downtown Arts Subcommittee and share what the committee has done. The commission is open to partnering in future projects and working together.

Walls for Murals: Dennis shared downtown locations, with measurements, that could be used for the next mural project. The project will involve painting on the wall, not a canvas. The wall selected is located near the corner of Main Ave. W. and Gooding St. W. It's in the alley behind Fuller's Law Office, owned by Shayne & Michelle Carpenter. Mike and Carolyn will draft the Call to Artists and present it at the next meeting.

Leon asked everyone to think about ideas for a 3-dimensional art project.
